

For example, we have a strong partnership with Ameren UE and they assist families with electric bills and affordable payment plans. We take advantage of this well attended event and ask for parents to give feedback on the parent and family engagement policy. Hazelwood East High School communicates regularly through phone blasts, emails, calendar updates and meetings to inform parents and stakeholders about all aspects of the school and community. During the school year, the community and families are encouraged to reach out, ask questions and take part in the EHS community. EHS has four Home School Communicators to ensure parent and family engagement is effective while also having ongoing community events.
