We provide curriculum nights for families along with weekly communications to parents. Teachers also send regular reports with academic and behavior updates for parents. We also send report cards at designated times and hold two-way communication via Parent Teacher Conferences and phone calls.

A variety of materials, including texts and workbooks for families, are purchased via Title funds. We provide training for families as well to help them better support their children throughout the school year and summer to lessen learning gaps. We provide a variety of learning opportunities for families via Parent University workshops. To be able to reach families in new ways, we plan to offer bus transportation for Larimore families to attend students' school sporting events. Since the sporting events are held throughout the district and many families do not have access to transportation, this will increase equity. This will also allow Larimore staff to share resource information and training to families on the bus and at the event itself.
